### **BUS DISPATCHER**

Application cut-off date: 5/9/2021

Performs supervisory duties related to directing bus operators and fixed route bus services, provides radio support and communications in coordinating the day-to-day operations of the Dallas Area Rapid Transit's (DART) bus service. Assures compliance with all applicable rules and procedures in the delivery of service to assure a safe and efficient operation.

Completes Texas basic peace officer licensing requirements in order to become a DRT Police Officer. This position is only for non-certified applicants

### **DART POLICE TELECOMMUNICATIONS**

Application cut-off date: 5/17/2021

This position is only for TCOLE certified applicants.

Performs telecommunication services for the department. Types all information into applicable system.

### **DATABASE ADMINISTRATOR**

Application cut-off date: 5/6/2021

Provides agency-wide Oracle & SQL Server database management functions, develops and administers backup recovery procedures, assist project teams with design & implementation of efficient & effective relational database storage schemas, maintains and optimizes existing application data repositories, & administers, installs & upgrades all Oracle & SQL Server instances.

### **FARE ENFORCEMENT OFFICER**

Application cut-off date: 5/17/2021

Inspects customer fares on DART rail system to ensure customers are riding with valid pass, responds with enforcement action when appropriate & deals with potentially rude, defensive uncooperative customers.

### **LOGISTICS PLANNER**

Application cut-off date: 5/4/2021

Plans and monitors stock levels and requisitions quantities to be purchased for Dallas Area Rapid Transit (DART). Material Control Division in support of bus operations. Plans and facilitates periodic planning sessions, coordinates initial provisioning for spare parts and integrates material planning needs with other functional areas.

### **MECHANIC – CENTRAL SUPPORT**

Application cut-off date: 5/9/2021

Performs assigned work relative to maintenance, repair and inspection of motor vehicles for the Dallas Area Rapid Transit's (DART) Fleet Services Division.

### **RECOVERY ADMINISTRATOR**

Application cut-off date: 5/12/2021

Oversees surplus and obsolete property and its disposition, discount sales, processes returns to vendors and conducts auctions for Dallas Area Rapid Transit's (DART) Material Control Division. Acts as C.O.T.R on auctioning contract.

### **SERVICER – NW**
